- d) Publishing an audio version of the Basic Text. BOC Chair, Same E.
 - a. Someone reached out asking to make a new audio recording of the S.L.A.A. Basic Text.
 - i. 60 second Round Robin held.
 - 1. Need more info.
 - 2. Great idea. Would be wonderful to have on Audible. Keep illegal activity to a minimum. Different voices, different ethnicities. May be great for revenue. Plus, keep misuse of copyright down.
 - 3. Who will own the copyright? How much will it cost? Is it going to be a "good" version? BCTC states it needs to have Digital Rights Management (DRM) be added the recording. 2 years away from a new edition to the Basic Text – Is now the time to make a recording or wait till the 50th Anniversary Edition is available? Please do it with multiple "voices" – women reading the women's stories, men reading the men's stories, gender-fluids reading the gender-fluid stories.
 - 4. Make it professional. Different voices. Sounds great.
 - 5. No to the S.L.A.A. Basic Text. Yes to the 50th Anniversary Edition. Many voices.
 - Love the idea. Audible can be vicious about keeping companies away from their field of business. Yes – to the 50th Anniversary Edition.
 - Get the 50th Anniversary Edition prepared. Going to be a good product because it will go through the new LCEP process. Group Effort with BPDC, BCTC, and BOC work collaboratively. Ask the person to send in a proposal on this.
 - a. Second shares:

- b. The 12x12 has been worked on for 15-18 years. Don't want to hold my breath that the 50th Anniversary Edition will be approved. Can work on both. This could be an immediate source of revenue for FWS which is desperately needed. Let's not limit ourselves.
- c. Don't know how long it is going to take the Second Edition to get approved. This could be a far quicker revenue source.
- d. **Point of Clarification** (**POC**): The 50th Anniversary Edition is finished. The Founder written Preface and edited first three chapters are done. Kate has reviewed the edits to her story. 10 or 11 new stories are to be added. And there are two years to go through the ABM Conference.
- e. **Point of Inquiry (POI)**: Are we voting on this or is it just feedback for the BOC? Feedback. Financial aspects would be nice to know. How much will it cost? How long will it take? This will take a couple of years to produce. This is a production.
- f. Jerry Clark from Echo Point Publishing sent the letter asking to develop the new audio recording of the Basic Text.
 i. Don't think FWS gives away our audio rights.
- g. Action Item: Sam E. and Rick B. Construct a response to Echo Point Publishing asking for many voices, DRM, length of time to produce, that the copyright to the audio recording will be retained by FWS, etc.
- e) Motion to add 2nd Whistleblower Investigator candidate Kathleen A. (CA)– **BDC Chair, Suzanne D.** (added 10 January 2023 to Dropbox)
 - a. Discussion held.
 - b. **Motion**: To appoint Katheen A. (CA) to the Whistle Blower Complaint team.
 - i. Vote: 8-0-0, Approved. Unanimous.
- f) Financial Documents review (Actual vs. Budget, Profit & Loss, and Balance Sheet):
 - a. Actual vs. Budget:
 - i. Literature sales are up (+\$19k) Contributions are down (-\$8k) and recovered from the bank the \$7k because of the fraudulent activity.
 - ii. **POI**: How much is budgeted for BOT travel to the ABM?
 - 1. 5k for housing + 10k for travel to the ABM = 15k total.
 - b. Profit and Loss (P&L): the P&L is the **same** as the Actual vs. Budget but without the budget part of the previous form.
 - i. The Prudent Reserve has grown by \$2k so far this fiscal year.
 - c. Balance Sheet:
 - i. This is where the Fellowship is at this moment financially.
 - ii. POC: Just voting on where we are from October 2023 till now.
 - d. **Motion**: Approve FWS Financials (P&L, Actual vs. Budget, and Balance Sheet) October December of 2023. .
 - i. Vote: 7-0-1, Approved.
 - ii. **POC**: The FWS website used to have a "carousel" that would rotate through several different announcements on the Landing Page.

- iii. **Action Item**: Hernan V. Forward the P&L and Balance Sheet to the FWS Newsletter for sending to the Fellowship.

- *i*) Motion: BPDC recommended 12 Steps in Plain Language **BPDC Chair Rick B**. (January 17, 2024):
 - a. Discussion held.
 - b. POI: There is an odd formatting with Step 10 being at the bottom of the page?
 - i. There are two versions. One that is for physical printing, one that is for digital publishing, and their formats are different to get them paginated correctly. (Folio style, pg. 1 and the opposite side will be the last page).
 - c. **Motion** (Rick B./Jack F): Approve the BPDC recommended 12 Steps in Plain Language and authorize it to be sold in print format at the price of the Anorexia Recovery Tools Booklet and the PDF version to be sold at the price of the Anorexia Booklets PDFs.
 - d. Vote: 8-0-0, Approved. Unanimously.
- j) Motion to approve Nicole M. join the BOC **BOC Chair, Sam E**. (from email on 29 January 2024)
 - a. Discussion held.
 - b. Vote: member Approved.
- k) Request of the CPIC (group conscience) to move the YouTube Channel from the CPIC to S.L.A.A. Virtual Intergroup (SVIG)* - CPIC Liaison, Jack F. (emailed on 8 January 2024) for a six-month trial period (friendly-amendment):
 - a. POI: How do we transfer a Conference asset to a corporation for a limited duration? (What if they do not want to return the Channel to the Conference?) [Is there a document that is signed?]
 - i. If there is a document, please point us in the right direction. The corporation was going to funnel the money back to the Fellowship. (No document to state this as of yet).
 - b. POI: Why is the Fellowship giving an asset over to another corporation?
 - i. Doesn't the Fellowship do that with *the Journal*? The Chair is part of an Intergroup and FWS benefits from that.
 - 1. **POC**: *The Journal* is a product of the Conference Journal Committee (CJC) and therefore part of the Conference structure.
 - c. **POI:** Who is the chair of S.L.A.A. Virtual?
 - i. It was Wnedy M. but that email complaint makes it unclear until the 2nd Sunday of the Month (tomorrow).
 - ii. **POI**: The S.L.A.A. Virtual Intergroup is incorporated just like FWS but in Australia, correct?
 - 1. Yes, It was formed 3 years ago. As part of the CPIC. (?)
 - iii. **POI**: How will the YouTube Channel be branded?

- 1. They will have their own statement saying that it is not affiliated with FWS. There is something on there about S.L.A.A. Virtual. That is not essentially a copyright. If you are going down the route of suing then you are doing it to a legal entity.
- iv. **POI**: The colors are the same as that of the Fellowship's, will these be changed?
 - 1. We can make friendly amendments.
 - 2. So, there are no documents stating that colors will be changed.
- v. **POI**: Will they be raising funds?
 - 1. They were hoping to stream the funds back into FWS.
 - 2. Maybe make a friendly amendment on funds raised as well.
 - 3. **POI**: There is nothing preventing that corporation from boycotting us if they disagree, right?
 - a. Yes.
- vi. **Motion**: Request of the Conference Public Information Committee (CPIC) to move the S.L.A.A. YouTube Channel to the S.L.A.A. Virtual Intergroup corporation.
 - 1. **Friendly Amendment**: That all funds created from the YouTube channel go directly to FWS, with the colors being changed from the Augustine Fellowship's colors or logo, with a time allowance of 6-months – so that in 6 months there will be a review (on how they go) to show all the money is accounted, forwarded to the office, and no marketing done as the Augustine Fellowship.
- vii. **Amended Motion**: Request of the Conference Public Information Committee (CPIC) to move the S.L.A.A. YouTube Channel to the S.L.A.A. Virtual Intergroup corporation. That all funds created from the YouTube channel go directly to FWS, with the colors being changed from the Augustine Fellowship's colors or logo, with a time allowance of 6-months – so that in 6 months there will be a review (on how they go) to show all the money is accounted for and sent to the Fellowship-Wide Services office.

 - i. Suggest a legal expert review this.
 - ii. There is a lot involved in maintaining this outreach.
 - iii. Need to see contracts.
 - iv. Would like much more paperwork on this.
 - v. Doesn't look ready for a vote.
 - vi. Not enough information.
 - vii. Difficult to wrap my head around this.
 - viii. **POC:** When a member Abstains from a vote, it doesn't count toward a motion, so potentially something can pass by 2-1-5.

 - c. Believe that the vote must be unanimous depending on the Charter.
