Chairs' Call Report

Since the last **F.W.S.** Newsletter Spring 2018 there have been two Conference Committees Chairs Calls on March 18th and May 20th. The calls demonstrate how busy and productive the fourteen (14) active Conference Committees have been this year especially with respect to draft literature on last year's and this year's Annual Business Meeting (ABM) Agenda. The <u>ABM Agenda Second Version</u> was distributed April 27th and is available on the F.W.S. website (slaafws.org).

There are sixteen (16) Conference Committees. Any member of S.L.A.A. may join one or more of these Conference Committees at any time by contacting the Conference Committee or the CCC chair via the F.W.S. website. The Conference Committees are:

There are two inactive Conference Committees: the CMRC for the last two years and the CHIC this year. However, a member with an interest in an inactive Conference Committee may restart a Conference Committee at any time. The ABC/M Schedule provides for three (3) meetings over three (3) days (Wed, Thurs and Fri) to conduct the annual business of a Conference Committee or to restart. The Chairs passed a motion on May 20th permitting observers, volunteers and other members at the ABC/M to attend the Chairs face-to-face meetings on Tuesday morning and Friday afternoon. This is in an effort to provide members interested in joining a Conference Committee and/or becoming a Chair, Vice-Chair or Co-Chair the opportunity to see what goes on at the meetings of the Chairs of Conference Committees.

Board of Trustees approves Non-BOT Member Service Rotation Policy

A policy length of service for non-BOT members on BOT committees was created and subsequently approved by the Board of Trustees at the May 12 meeting.

The policy allows non-BOT members to serve for up to five consecutive conference years on up to two committees at one time. Upon completion of the five-year period, members shall rotate out of BOT committee service for a minimum of one year. After the minimum one year, members become eligible again for this type of 12-Step work.

The full policy appears below.

The Augustine Fellowship, S.L.A.A., Fellowship-Wide Services, Inc.

Scope: The Augustine Fellowship, S.L.A.A., Fellowship-Wide Services, Inc. (F.W.S.) created a policy for length of service for non-BOT (Board of Trustee) members on BOT Committees.

Policy:

Members may be elected to the Board of Trustees and serve two full three (3) year terms, plus the prior appointed period, before they must step away for a minimum of one (1) year.

The BOT Committees provide a ground for members to learn more about the Board of Trustees, and, for some, to become members of the Board of Trustees. In light of that, the spirit of rotation of service should be followed.

Non-BOT members will be allowed to service for up to five (5) consecutive conference years prior to having to rotate off of service for one (1) conference year. During their time of service as non-BOT members, they may not service on more than two (2) Committees at any time.

After completing their one (1) year of rotation off of the Committees, they are eligible to resume for another five (5) year period before having to rotate off again.

For those members who have exceeded or will exceed the time frame during the 2017-18 Conference Year, an exception will be made whereby they can serve out the remainder of the current conference year, and one (1) additional year, prior to having to rotate off of service as a non-BOT member for one (1) year.
