### **Board of Trustees Chair's Message**

Jaclyn R. has resigned from the Board of Trustees (BOT) for personal reasons and Christina M. (new Mom for the second time!) has gone on maternity leave so the BOT is currently two members short of having a full Board.

The BOT has signed the contract with the Hilton Arden West hotel in Sacramento, CA to host the 2022 ABC/M from August 9 thru August 12, 2022. This year, for the first in-person ABC/M in three years, the BOT will fully subsidize all delegates' room and board (for double occupancy) and for those delegates traveling to the ABC/M from outside of North America, the ABC/M registration fee of \$285 has been waived for this year.

The LifeSaver Program has raised almost \$80,000 from member, group and intergroup contributions since it began back in April 2020, helping the Fellowship realize close to \$160,000 in total revenue including the pledged matching funds.

- Gabriel G. (CA) Gabriel has taken over as the acting Secretary during Christina's maternity leave and he chairs the Board Programs and Membership Committee (BPMC);
- Hernan V. (CA) Hernan is the Chair of the Board Outreach Committee (BOC);
- Suzanne D. (TX) Suzanne is the Chair of the Board Publishing and Distribution Committee (BPDC);
- Juanita J. (VA) was assigned to sit on the BCTC and the BPMC; and
- Seth S. (MA) I am the Board of Trustees Chair, President of the corporation and Chair of the Board Development Committee (BDC), the Board Copyright and Translation Committee (BCTC) and the acting Chair of the Board Technology Committee.

**Purpose:** To identify the unique challenges experienced by long term members and provide tangible solutions to keep those members engaged and active in S.L.A.A. **Progress:** We have an outline, with an Introduction, Conclusion, and one of two major sections (identifying the challenges) approved by the Committee. We are actively working (at each monthly meeting) to workshop and approve the remaining major section (solutions). Originally conceptualized as a "pamphlet," a "booklet" now seems required to cover the challenges and solutions.

**Project Name:** Fantasy Subcommittee

**Purpose:** To gather, review, edit, and re-write currently-available literature on the "fantasy" aspects of sex and love addiction and make it readily available to the Fellowship as "Conference-Approved Literature." Three current main projects: 1) Editing the Characteristics of Fantasy Addiction for submission to the CLC; 2) Editing the Promises of Healing Fantasy Addiction for submission to the CLC; 3) Conducting Reading Meetings to evaluate the 31 articles on fantasy addiction from *The Journal* for inclusion in a booklet on the topic.

**Progress:** The Subcommittee meets weekly to continue this work. An IFD for this year's ABM is that the Fantasy Subcommittee become its own committee. It is likely that this will be voted on at this year's ABM.

**Budget:** The Committee made no budget request this year.

### Conference Steps, Traditions, and Concepts Committee (CSTCC): Questions from the Fellowship

The CSTCC welcomes Questions from the Fellowship concerning the Twelve Steps, Twelve Traditions and Twelve Concepts. Our responses are individual, and neither binding nor authoritative. We do not speak for the whole of S.L.A.A.

### **Question from the Fellowship (Committee Reference #2021-4):**

The person who founded and runs a virtual writing group with associated video groups has recently begun requiring that members allow them to collect the written shares, with the purpose of utilizing the writings in a recovery-based book. The members' written shares are also being used to create personalized merchandise (mugs, t-shirts, etc.) which are then offered for sale to the group members.

I feel this is a breach of members' anonymity and believe that using individual members' private information for personal gain is wrong. Are S.L.A.A. virtual writing and video groups subject to the same guidelines / regulations / traditions as regular face to face meetings? Please advise on how the Steps, Traditions or Concepts apply to this situation.

#### Response #1:

According to the Traditions, anyone who doesn't like this meeting does not have to attend, and, is free to start their own meeting that does follow their understanding of the traditions. The meeting is free to use and refer to S.L.A.A. literature if they find it helpful.

Meetings are autonomous and anyone who finds the literature helpful has a right to share it with anyone they want, as long as they are not reproducing it, and I think it's ok if they are purchasing it from Amazon or S.L.A.A. and selling it to their members at cost. That's what we do.

I suppose it's unscrupulous if they are selling it at a profit margin, but even that is really none of our business.

### Response #2:

If this meeting or group represents itself as an S.L.A.A. meeting, then it is clearly in breach of the Traditions. If the group is simply a writing group that happens to be mostly S.L.A.A. members in its membership, there is no breach.

If this is a meeting: Tradition Three tells us that the only requirement for membership is a desire to stop living out a pattern of sex and love addiction. Therefore, the meeting cannot require anything else of its participants. Tradition Twelve tells us that the spiritual foundation of our program is anonymity, and Tradition Eleven tells us we must guard the anonymity of our members with special care, so that tells me that the words of our members in shares should not be reproduced or sold. Tradition Five tells us that the primary purpose of a group is to carry the message, so creating a book or selling merchandise is straying from the primary purpose. Tradition Two tells us our groups should have no other affiliation besides to S.L.A.A., and Tradition Ten says we have no opinions on outside issues. The creation and sale of a book of members shares, as well the creation of merchandise from member shares, both seem to take us outside of the issues we are here in S.L.A.A. to treat, affiliating ourselves with outside non-conference approved literature, and endangering the clarity of the message of S.L.A.A. to someone who may be encountering it for the first time.

There are many reasons why the actions stated should not be carried out if this group is a meeting of S.L.A.A.

However, if this online meeting is not purporting itself as an S.L.A.A. meeting, and it is simply presenting itself as a group of people, some of which are in S.L.A.A., who get together to talk about recovery and anything else they please...they can choose what their primary purpose as an organization is, and how they choose to raise money etc. If some members of S.L.A.A. are members of this outside group, that doesn't mean that S.L.A.A.'s Traditions must be followed by that outside group.

S.L.A.A. has no enforcement body and cannot prevent people from breaking Traditions. However, if this group calls itself an S.L.A.A. meeting, they should definitely stop the actions stated.

### Response #3:

"Each group has but one primary purpose — to carry its message to the sex and love addict who still suffers: Tradition 5. Not the message; its message. An S.L.A.A. group may collect and share its members' experience, strength and hope in carrying its message. For example, the approved Suggestions for Public Outreach suggest groups and intergroups "12. Post anonymous videos about sex and love addiction and recovery on the Internet. .....that share real S.L.A.A. stories of the insanity of addiction and the serenity of recovery."

The CSTCC has considered the role of anonymity in memoirs before. If the proposed book is available to the public, there are two clear options that satisfy Tradition Eleven (Anonymity). It is acceptable Twelfth Step work to spread the message by telling our personal story as long as the member does not disclose their real name or any other information that makes them identifiable and they make clear that they do not speak for S.L.A.A. as a whole. If the writer(s)' real name will be disclosed in the publication, it is important not to mention S.L.A.A. or disclose participation in Twelve Step at all.

Tradition Eleven is a suggestion and not a legal requirement. Members do sometimes choose to break their own anonymity at the level of public media. Each such incident is an outside matter on which S.L.A.A. has no opinion and seeks no controversy.

If the anthology of member writings is only for distribution within the S.L.A.A. group, then Tradition Twelve tells us that it is up to each individual to determine how they will handle their own anonymity. While it is never appropriate to break another member's anonymity without their permission, we are free to disclose our own membership however we see fit, if we choose, provided that we remain anonymous at the level of public media.

The question asks if an S.L.A.A. group can require (not merely request) its members to contribute their writings to the group. Tradition Four tells us that each group should be autonomous except in matters affecting other groups or S.L.A.A. as a whole. Members who do not want to donate their writings are free to "vote with their feet" and leave the group and/or try to remove the requirement by calling for a group conscience. Therefore, it is highly unlikely the decisions of this S.L.A.A. group affects other groups or S.L.A.A. as a whole.

For this group's purpose there is but one ultimate authority — a loving God as this Power may be expressed through their group conscience: Tradition Two. If the group's decisions are made by informed group conscience, no-one else has the right to judge. Every S.L.A.A. group has autonomy to experiment with new ways to achieve its primary purpose including to make its own mistakes.

Every S.L.A.A. group ought to be fully self-supporting, declining outside contributions: Tradition Seven. Can a S.L.A.A. group raise funds by the sale of merchandise to members? This is a complex legal question beyond the scope of this committee, but the simplified answer is: usually yes. There is a large market for recovery merchandise in other fellowships.

It is unclear how the sale of merchandise (or literature) is for "personal gain". However, the sale of Recovery related products by individuals - who may or may not also be members - does occur in other fellowships. If that is happening to S.L.A.A. - and there is no evidence that it is - that is a commercial matter for the Board of Trustees to consider.

### Response #4:

- 1. I believe virtual meetings are subject to the same Steps, Traditions and Concepts as face-to-face meetings, but the Steps, Traditions and Concepts are suggestions, not rules or regulations. Tradition Four basically says each meeting is free to make its own mistakes as long as they don't affect S.L.A.A. as a whole.
- 2. In my opinion, anonymity applies to each person's identity or position, not to information on how they acted out or what works for them in recovery. If parts of their shares make it into a recovery-based book I don't think it violates any of the Step, Traditions or Concepts as long as there is nothing in the writing that provides information about the person. For example: saying an engineer used his work computer to act out, vs using a first name and name of the company and more details about how he acted out that might identify him.

- 3. I also believe that anyone coming to the meeting should be notified that their shares may be anonymized and give them the option of staying in the meeting and sharing or leaving.
- 4. The creation of merchandise seems like a breach of the Sixth Tradition on outside enterprises, especially since they are being offered for sale to group members there may be pressure to buy.

All that said, if this is a writing group (and not a meeting) and all participants are aware that what they share may be used in either a book or merchandise, and there is no personally identifiable information - I don't believe this violates the Steps, Traditions or Concepts since it does not purport to be a meeting.

There are other legal, copyright aspects of using someone else's story that I am not qualified to speak on, the author may need to get a signed release from the person who's story they share.

### Response #5:

I believe whether the meeting is virtual or in person, if it is an S.L.A.A. meeting and not just a writing group, they must follow the same Steps and Traditions to protect the member safety and provide anonymity.

### **Question from the Fellowship (Committee Reference #2021-5):**

It has come to my attention that a few Intergroup websites may not be adhering to the traditions. On a couple of the intergroup websites the following issues are taking place:

- The copyright notice does not name the intergroup, it only says Sex and Love Addicts Anonymous, which could be confusing.
- There are several lengthy excerpts from copyrighted literature under the Newcomers menu.
- They sell AA literature alongside S.L.A.A. literature under the heading S.L.A.A. books.
- Free pamphlets and Newcomer Packets are being sold rather than given away.

After reviewing the Guidelines for Local S.L.A.A. websites and S.L.A.A. and Social Media, I wonder if these websites are breaking Traditions? And is there anything that we can do about this?

#### Response #1:

The issue of AA literature is illuminated in the F.W.S. approved S.L.A.A. Twelve Step Workbook. In the workbook AA literature is among the suggested readings. Tradition Five states "Each group has but one primary purpose -- to carry its message to the sex and love addict who still suffers." AA has always and continues to be an optional part of that message if a group conscious so approves it.

### Response #2:

This committee does not police or control any intergroups, who are making a lot of efforts to have a meeting in the first place. One intergroup may contact another intergroup to get help in developing a more S.L.A.A. Traditions oriented website regarding AA versus S.L.A.A. literature. In my opinion, it is totally acceptable to refer to AA literature as S.L.A.A. literature.

### Response #3:

This question itself is contrary to the letter and spirit of the Traditions.

No, there is nothing we can do about a member, a group, or an intergroup. We cannot tell them how to work their program. We cannot tell anyone how to work the Steps. We cannot tell anyone how to adhere to the Traditions. We honor the autonomy of every meeting.

We are a program of attraction rather than promotion. The suggestion in this question that we somehow enforce the suggestions in the Traditions is itself a failure to adhere to the Traditions.

The CSTCC welcomes Questions from the Fellowship concerning the Twelve Steps, Twelve Traditions and Twelve Concepts. Our responses are individual, and neither binding nor authoritative. We do not speak for the whole of S.L.A.A.

- The newsletter is not a recovery-oriented publication per se and not to be confused with the *Journal*, which publishes articles of recovery.

### Read about the New Recovery Book

There has been some confusion between the 50<sup>th</sup>–anniversary edition of the BT and a new book on recovery that is in the works, CLC project 083. Some of that misinformation is understandable because the direction the projects have taken has changed over the last year. The bullet points below should clarify any misunderstandings.

- 1. There are not going to be multiple different versions of the Basic Text. Any plan resembling that has been scrapped in light of the discussion at the Annual Business Meeting in 2021. To be clear, there is to be a 50<sup>th</sup>-anniversary edition of the book (described above) but it will not otherwise be revised. The expectation is that the 50<sup>th</sup>-anniversary edition text will become the second edition of the BT. (AA is working on its fifth edition.) At that point, we expect the current, first edition of the book will be supplanted by the 2<sup>nd</sup> edition—just as AA did many years ago—and the first edition will go out of print.
- 2. The 083 project is NOT a reworking of the BT; it will be an entirely new book. It was made perfectly clear at the 2021 ABM that trying to create an updated BT was futile. But the need for a new book that addresses the needs of the current fellowship has been clearly and repeatedly voiced in IFD feedback over decades and in last year's survey, "To Change or Not to Change." Project 083 will cover program basics, but will also address facets of our addiction that are not addressed in the Basic Text, such as anorexia, internet issues, and fantasy addiction. It also will address long-term sobriety, aging, and healthy relationships, and will reflect the diversity represented in our current membership. This exciting project is only in the planning stages. More will be revealed.

### Considerations for Submission of a Motion/IFD to the 2022 ABM Agenda

The CCC (Conference Charter Committee) and the ARS (Agenda Review Subcommittee) request that you respect the ABM Agenda Submission Process by submitting all Motions/IFDs in a timely manner.

Please submit a Motion/IFD no later than <u>April 11, 2022</u>, the suggested date or, if possible, before. There are advantages to submitting a Motion/IFD by the suggested date including:

- 1. The ARS or others will be able to help the Submitter revise a Motion/IFD, if required.
- 2. The ARS and CCC can assist the Submitter in having a Motion/IFD placed on the ABM Agenda Second Version.
- 3. Allows time for comments from Conference Committees on a Motion/IFD to be placed on the ABM Agenda Third Version.
- 4. Delegates and other Conference members will have the opportunity to fully review the Motion/IFD prior to the ABM.

Alternatively, submitting a Motion/IFD after the suggested submission due date or submitting a Motion/IFD just prior to the 7PM deadline at the start of the ABM creates several disadvantages, including:

- 1. The Fellowship will not be able to provide comments regarding the Motion/IFD prior to the ABM and an informed group conscience will not be possible.
- 2. Places an undue burden on members of the ARS and the CCC who are preparing the ABM Agenda Fourth Version for the ABM for distribution the next morning.
- 3. A 'last minute submission' does not provide time for revision thus jeopardizing the chance of the Motion/IFD being placed on the ABM Agenda Fourth Version.

All submissions will continue to be accepted for review until the 7:00 pm deadline, <u>August 9, 2022</u> (Central Time Zone).



- comply with the CPIC Guidelines for Video

### To be elected to the Board :

The Bylaws require the member to have three years of continuous, self-defined sobriety in S.L.A.A. (Non-S.L.A.A. members can be on the Board). See below \*\*\*

### Board service commitments:

- Have a working knowledge of the 12 Steps and the 12 Traditions of S.L.A.A.
- Are willing to commit to a three-year term.
- Travel to the Annual Business Conference/Meeting (ABC/M) (7 days) each summer during their term to participate in Board meetings 3 days before and 1 day after the ABC/M (expenses paid).
- Are willing to participate in a minimum of six 3-hour Board conference calls plus BOT Committee meetings and many email discussions plus liaise with several Conference committees.
- Have at least 20-30 hours a month available for BOT service.

### The following list is experience based items that the BDC recommends for potential board members but are not required by the Bylaws:

- Have skills and abilities valuable to the organization.
- Have served as non-BOT member of a BOT Committee for at least 3 months.
- work well in a group dynamic.
- Have a functional understanding of group conscience.
- Have experience in S.L.A.A. service at the Intergroup and/or Conference level.
- Have served as a delegate at the Conference level for at least one year.

### Requirements for Non S.L.A.A. Board Members :

Those Trustees who are not qualified members of the Fellowship shall be persons from the community at large who have made substantial contributions to the purposes of the Fellowship principles stated in the Twelve Traditions and Twelve Concepts.

### \*\*\* BDC recommends for Non-S.L.A.A. members :

- To know and love the S.L.A.A. Fellowship for how it has helped family, friends or clients.
- To have skills from such areas as legal, financial and/or business fields.
- To bring an added perspective due to being outside the S.L.A.A. program.
