Whereas, S.L.A.A. desires to grant such permission in accordance with the terms specified below.

Now, therefore, the parties agree as follows:

1. Applicant acknowledges and agrees that S.L.A.A. is the sole owner of all U.S. and foreign copyrights in the above-identified copyrighted work and that such copyrights are valid and in force.
2. Applicant agrees and hereby does assign all copyright in the translation to S.L.A.A., as evidenced on the attached Assignment form (**Exhibit A**), signed by Applicant.
3. S.L.A.A. grants Applicant an exclusive license to reproduce and distribute the translation in the exact form in which it was submitted to S.L.A.A. only, in the country identified above only.
4. S.L.A.A. grants Applicant the right to enforce the copyright in the translation in the Applicant's own name in the country identified above, including the right to file suit for infringement in Applicant's own name. Applicant agrees to notify S.L.A.A. in writing of any infringement of said copyright in the country identified above as soon as such infringement comes to the attention of Applicant.
5. Applicant agrees that all copies of the translated work will bear the trademarked S.L.A.A. Logo as reproduced on the top of this document.
6. Applicant agrees that all copies of the translated work will bear the following notice on the inside cover page, appropriately dated, in English *and* in the language of the translation (See **Exhibit B** for appropriate dating).

7. Applicant agrees to send three hard copies of the translation and one electronic copy in the form in which it is published to S.L.A.A. within two weeks of the publication date. Applicant agrees to simultaneously notify S.L.A.A. of the publication date.
8. Applicant acknowledges and agrees that this license may be revoked by S.L.A.A. at any time for any reason, upon 30 days written notice. Unless revoked, the duration of this Agreement shall be one year, renewing for subsequent, one year periods automatically without action of the parties.
9. In consideration of the license granted herein, Applicant shall pay as a royalty 10% of the sale proceeds of the translated literature when literature from a printing run has been sold. Payment shall be made in U.S. dollars to S.L.A.A. at the FWS office.
10. This License Agreement must be executed in duplicate and returned to S.L.A.A. The assignment attached as **Exhibit A** must also be signed and returned with this License Agreement. S.L.A.A.'s consent to this request will be effective on the date of S.L.A.A.'s signature. One signed copy will be returned to Applicant.
