## **BUSINESS**

#### **ELEVATED PRIORITY:**

- a) Vote on Non-BOT Board Committee Members. None to vote.
- b) IFD: The BFC has voted to unanimously recommend that the BOT pause free shipping on orders \$100 or more 3-5 months to allow time to determine impact of fully subsidizing shipping on those orders and potential alternatives. (Chris D, 1 Mar 2025)

## **Round Robin:**

- For international orders, we could potentially sell through Amazon within the country of the purchaser or work with their local intergroups to print-on-demand and sell items there. Or house literature to be sold there.
- Sales system is not sophisticated enough to just turn off free international shipping without turning off domestic shipping for that time period. Would not be able to differentiate one from the other.
- Some publishers may not print the Basic Text because of the content.
- Reasons for offering free shipping were to help with literature sales at a time sales were down and to offer outreach to others internationally because Intergroups were saying shipping is so expensive.

- It will take some time to figure out how much shipping is costing the Fellowship. Pausing both domestic and international subsidies will allow time to study.
- A steering committee would need to be formed to get all the data needed to set up publishing internationally.
- May just cause a pause in sales that would make it difficult to get the data needed anyway.
- Create an international bookstore. Give advance notice so that buyers could stock up.
- It was noted that this is not an emergency measure and the subsidy makes it possible to offer outreach internationally.
- We depend on those orders so we should make sure what we are doing before taking a pause.
- Will find out how much sales we had overall to compare to the amount of shipping we paid.

**Consensus:** The Board to continue discussion regarding possible solutions.

- c) MOTION: The 2025 pre-ABC/M BOT meeting will be split into five 3.5-hour sessions, with dates to be scheduled promptly. (Phoenix/Jack, 2 Feb 2025) Round Robin:
  - Would be more balanced than having 16 hrs packed into the weekend before the ABC/M. It would help to avoid fatigue.
  - Would be difficult to coordinate between all the different time zones. Some compromise would need to be made to satisfy each member's schedule.
  - Some feel these additional meetings would add to the workload that the board members already have and it would keep things simpler to just have it the weekend of the ABC/M.
  - Spreading the meeting time out could complicate matters that need attending to in a timely manner right before the ABM.
  - Spreading things out could work better for those who have other workloads the weekend of the ABC/M.
  - May be possible to not need all of the meetings.

#### Comments:

The board has found it more difficult virtually as compared to meeting in person to get our fiduciary responsibilities completed before the end of the ABC/M.

Vote: 6-1-1, Minority Heard, Vote: 6-2-0, motion passed.

**Action Item:** Jeff will prepare an estimate to include in the 2025 budget for the Board Members to meet in person before the ABC/M to make necessary preparations.

 MOTION: Eliminate Hazelton's special pricing of \$11.50 per Basic Text and charge them the same price as others based on the amount they order. (Chris D./Phoenix G., 3 Oct 2024)

## **Round Robin:**

- Hazleton pays for their own shipping making their cost about the same as other sellers.
- Used to purchase a pallet but they no longer have that special reason to have a special rate. There's been a big decrease in orders.

**Vote**: 8-0-0, passed unanimously.

- e) **MOTION**: Pay printing costs of the conference-approved literature, "The Importance of Making Outreach Calls" (Phoenix G./Jack F., 27 Nov 2024).
  - For unknown reasons, this pamphlet was never printed.
  - Should move forward with printing because the literature had been conference approved.
  - Great piece of literature that took several years to get approved by the conference.
  - Price was set at 50 cents (USD) for the digital version, 75 cents (USD) for the printed version.

#### Round Robin:

- Need to keep watch on costs.
- Need to be able to help the Fellowship with this new tool.
- Can be printed in house.
- Printed version is in tri-fold format on legal size paper.
- The pamphlet will fill a gap in the diversity of literature that SLAA has available.
- At 50 cents for the digital version it may sell better and reduce piracy.

**Proposed amendment:** Pay printing costs of the conference-approved literature, "The Importance of Making Outreach Calls", to be sold at 50 cents (USD) per Digital copy and 75 cents (USD) per Print copy. - Accepted (Phoenix G. / Jack F.) **Vote:** 8-0-0, passed unanimously.

- f) **MOTION**: To make the 90-day trial period from the first meeting for all new non-BOT members of Board Committees with updates to the Board Committee flier and the Board Committee Application. (Rick B./Jack F., 14 Sept 2024, previously tabled) **Round Robin**:
  - This was done in the past. This would just make it into a policy and make it standardized.
  - Friendly amendment to change the grammar to say, "To establish a 90-day trial period, starting from the first meeting, for all new non-BOT members of Board Committees, with corresponding updates to the Board Committee flyer and the Board Committee Application." Declined.
  - Plan to vote "yes" whether there is a friendly amendment or not.
  - Generally in favor of the motion.
  - Motion only applies to new applicants, motions are not retroactive.
  - In favor either way.

Vote: 8-0-0, original motion passed unanimously.

- g) **MOTION**: The list of membership roles stated in the BOT motion that created the BABMPC be non-exclusive. (Phoenix G./Chris D., 4 Oct 2024, previously tabled) **Round Robin**:
  - Be inclusive
  - The committee chair should be the one to decide if others can join the group in addition to the application process.
  - Board members should be able to attend.
  - Should not be totally non-exclusive as the motion says.
  - This group is different from any other committee. People on the committee are predetermined by their role.
  - Could make the committee Board heavy.

**Motion** to table: 3-5-0, motion failed.

**Proposed amendment:** The list of membership roles for the BABMPC shall not be exclusive to board members; however, any non-pre-approved roles of BOT attendees shall not have voting rights. - **Accepted.** 

#### **Round Robin:**

- Could be a bit limiting.
- Anyone can attend but not everyone will have voting rights.

Vote: 7-1-0, no minority opinion, Accepted.

Non-substantive changes are edits that do not alter the intent, meaning, or fundamental provisions of a policy. Examples include: Correcting typographical errors, grammatical issues, or formatting inconsistencies and updating references to addresses or committee titles, for example. The Executive Director will notify the BOT of any non-substantive changes at the next scheduled BOT meeting or before. A record of all non-substantive changes will be maintained and made available for review. (Chris/John, 18 Nov 2024)
